Locker Terms and Conditions

All lockers are owned by the Herts Bowling Club and can be rented on a seasonal basis at a fee set by the Board of Directors. From 1st April 2024 the fee is £5 per year. A £10 refundable deposit will be required for the key.

The contents of all lockers must be emptied at the end of the rental period with the locker key returned to the office or the bar with the locker **NUMBER ATTACHED. If this process is not completed, then the refundable deposit will be forfeited.**

Nothing must be affixed or stuck on the door of the locker by the member,

The members name and the expiry date of the rental period to be affixed to the locker door by the club Locker manager.

For FULL members the locker only needs to be emptied if the fee has not been paid by the 1st May each year and full membership has not been renewed by the 1st May.

For Winter Indoor members the fee is valid from the 1st September to the 30th May the following year upon which the contents of the locker must be removed. At the end of the Indoor season the locker must be emptied, the locker key returned to the office or the bar with the locker **NUMBER ATTACHED If this is not completed then the refundable deposit would be forfeited.**

The locker number will be held for the member until the start of the next Winter Indoor season unless at the start of the next season the renewal fee or membership has not been paid by the 31st October. If an Indoor member wishes to keep their bowling equipment in the locker during the summer then the Locker Manager must be informed and permission granted. If this is not completed then the refundable deposit would be forfeited.

The locker would then be allocated to another member.

If the member has paid for the Summer Indoor season together with the Winter Indoor season then the fee is valid for 12 months until the 30th September. The locker **only needs to be emptied** if the £5 fee has not been paid by the 1st September each year and full membership has not been renewed by the 1st October.

For Outdoor members the fee is valid from the 1st April till the 30th September.

For all seasons / rental period: If after 4 weeks from the expiry date of the rental period the fee has not been paid and if the locker is locked then the locker will be opened and the contents removed, and acquired by the club and sold. The money raised will be donated to the club fund.

The refundable deposit will be forfeited.

If for any reason the member has been unable to renew the rental fee then someone must inform the club administrator the reason why the fee has not been paid. The problem would be discussed with a Board member and a final decision made as to what action may be taken.
